1 Strike lines 78 to 92, inclusive, and insert the following in lieu
2 thereof:

3 "Sec. 4. Subdivision (9) of section 53-278a of the general statutes is
4 repealed and the following is substituted in lieu thereof:

5 (9) "Peace officer" means a municipal or state police officer, sheriff,
6 deputy sheriff or chief inspector or inspector in the Division of
7 Criminal Justice or judicial marshal in the performance of the duties of
8 a judicial marshal.

9 Sec. 5. Subdivision (9) of section 53a-3 of the general statutes is
10 repealed and the following is substituted in lieu thereof:

11 (9) "Peace officer" means a member of the Division of State Police
12 within the Department of Public Safety or an organized local police
13 department, a chief inspector or inspector in the Division of Criminal
14 Justice, a sheriff, deputy sheriff [or special deputy sheriff] or judicial

15 marshal in the performance of the duties of a judicial marshal, a
16 conservation officer or"

17 Strike sections 6 to 119, inclusive, in their entirety and renumber the
18 remaining sections accordingly

19 Strike lines 3401 to 3403, inclusive, and insert the following in lieu
20 thereof:

21 "Justice, a sheriff or deputy sheriff or judicial marshal in the
22 performance of the duties of a judicial marshal, a constable who
23 performs criminal law enforcement"

24 Strike sections 123 and 124 in their entirety and renumber the
25 remaining sections accordingly

26 Strike sections 126 to 129, inclusive, in their entirety and renumber
27 the remaining sections accordingly

28 Strike sections 133 to 138, inclusive, in their entirety and renumber
29 the remaining sections accordingly and insert the following:

30 "Sec. 133. Subsection (l) of section 5-259 of the general statutes is
31 repealed and the following is substituted in lieu thereof:

32 (l) (1) Effective July 1, 1996, any deputies or special deputies
33 appointed pursuant to section 6-37 or section 6-43, shall be allowed to
34 participate in the plan or plans procured by the Comptroller pursuant
35 to subsection (a) of this section. Such participation shall be voluntary
36 and the participant shall pay the full cost of the coverage under such
37 plan.

38 (2) Effective October 1, 2000, any judicial marshal shall be allowed
39 to participate in the plan or plans procured by the Comptroller
40 pursuant to subsection (a) of this section. Such participation shall be
41 voluntary and the participant shall pay the full cost of the coverage
42 under such plan unless and until the judicial marshals participate in
43 the plan or plans procured by the Comptroller under section 5-259

44 through collective bargaining negotiations pursuant to subsection (f) of
45 section 5-278."

46 Strike sections 140 to 143, inclusive, in their entirety, and renumber
47 the remaining sections accordingly

48 Strike lines 3555 to 3563, inclusive, and insert the following in lieu
49 thereof:

50 "Sec. 132. Sections 6-32, 6-32a, 6-41 and 6-44 of the general statutes
51 are repealed.

52 Sec. 133. This act shall take effect July 1, 2000."
