"An Act Providing A Property Tax Abatement For Certain Personal Property, Technical Corrections Regarding The Veterans Exemption And Revisions To Requirements Of Boards Of Assessment Appeals And Establishing A Property Tax Credit Relief Program For Firefighters And Emergency Medical Personnel."

1 Strike out section 10 in its entirety and insert the following in lieu
2 thereof:

3 "Sec. 10. Section 6 of public act 99-272 is repealed and the following
4 is substituted in lieu thereof:

5 (a) The legislative body of any municipality may establish, by
6 ordinance, a program to [abate up to one thousand dollars in property
7 taxes due for any fiscal year for a resident of the municipality] provide
8 property tax relief for the nonsalaried local director of civil
9 preparedness and for individuals who [volunteers his or her]

10 volunteer their services as a firefighter, emergency medical technician,
11 paramedic or ambulance driver in the municipality. Such tax relief
12 may provide either (a) an abatement of up to one thousand dollars in
13 property taxes due for any fiscal year, or (b) an exemption applicable
14 to the assessed value of real or personal property up to an amount
15 equal to the quotient of one million dollars divided by the mill rate, in
16 effect at the time of assessment, expressed as a whole number of
17 dollars per one thousand dollars of assessed value. Any ordinance may
18 authorize interlocal agreements for the purpose of providing property
19 tax relief to such volunteers who live in one municipality but volunteer
20 their services in another municipality.

21 (b) As used in this section:

22 (1) "Ambulance driver" means a person whose primary function is
23 driving an ambulance;

24 (2) "Emergency medical technician" means an individual who has
25 successfully completed the training requirements established by the
26 Commissioner of Public Health and been certified by the Department
27 of Public Health;

28 (3) "Firefighter" means a unpaid member of an organized fire
29 district;

30 (4) "Local director of civil preparedness" means the director
31 appointed pursuant to section 28-7;

32 (5) "Paramedic" means a person licensed under section 20-106ll."

35 In line 441 before the period insert the following "and section 10
36 shall be applicable to assessment years commencing October 1, 1999"
