 - 6 "Sec. 501. Section 14-318 of the general statutes is repealed and the
 - 7 following is substituted in lieu thereof (*Effective October 1, 2003*):
 - 8 Terms used in this chapter shall be construed as follows, unless

9 another construction is clearly apparent from the language or context
10 in which the term is used or unless the construction is inconsistent
11 with the manifest intention of the General Assembly:

12 (1) The following terms shall be construed as they are defined in
13 section 14-1: "Fuels", "motor vehicle" and "person";

14 (2) "Commissioner" means the Commissioner of Consumer
15 Protection or any assistant to the Commissioner of Consumer
16 Protection who is designated and authorized by, and who is acting for,
17 the Commissioner of Consumer Protection;

18 (3) "Distributor" means any person, wherever resident or located,
19 who imports fuels or causes fuels to be imported into this state, for sale
20 or use; a person who produces, refines, manufactures or compounds
21 fuels within this state; and a person who distributes gasoline by tank
22 wagon in this state;

23 (4) "Local authority" means the selectmen or town manager of a
24 town, the mayor of a city or the warden of a borough or other board or
25 authority designated by local charter, regulation or ordinance, except
26 in any town or city having a zoning commission and a board of
27 appeals, [in which event] "local authority" means the board of appeals;

28 (5) "United States Government Motor Gasoline" means gasoline
29 which is or may be prescribed by the federal specification board of the
30 United States government for use as fuel for motor vehicle, motor boat
31 and similar engines;

32 (6) "United States Aviation Gasoline, Domestic Grade" means that
33 gasoline which is or may be prescribed by the federal specification
34 board of the United States government for use as aviation fuel; and

35 (7) "Retail dealer" means any person operating a service station,
36 filling station, store, garage or other place of business for the sale of
37 motor fuel for delivery into the service tank or tanks of any vehicle
38 propelled by an internal combustion engine."
