AN ACT CONCERNING ALLOCATION OF THE TEMPORARY ASSISTANCE FOR NEEDY FAMILIES HIGH PERFORMANCE BONUS MONEYS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. (*Effective from passage*) (a) For the fiscal year ending June
2 30, 2004, the sum of \$11,745,032 received by the state of Connecticut,
3 from the federal government, for the TANF high performance bonus
4 payments for welfare to work, is appropriated to the Department of
5 Social Services to be used for the purposes of the TANF Program, as
6 defined in Public Law 104-193.

7 (b) The sum of \$500,000 of the funds appropriated to the
8 Department of Social Services in subsection (a) of section 86 of public
9 act 02-7 of the May 9 special session, and carried forward pursuant to
10 subsection (b) of said section 86, for the Jobs Funnel, shall be used for
11 the Fatherhood Initiative. Such funds shall not lapse on June 30, 2004,
12 and shall be available for expenditure as provided in subsection (d) of
13 this section during the fiscal year ending June 30, 2005.

14 (c) The funds appropriated in subsection (a) of this section shall not

15 lapse on June 30, 2004, and such funds shall continue to be available
 16 for expenditure for such purposes during the fiscal year ending June
 17 30, 2005.

18 (d) The funds appropriated in subsection (a) of this section and the
 19 funds carried forward in subsection (b) of this section are available for
 20 expenditure as follows:
