**"AN ACT CONCERNING PARENTAL INVOLVEMENT REPORTING
IN SCHOOL PROFILES."**

1 After the last section, add the following and renumber sections and
2 internal references accordingly:

3 "Sec. 501. (NEW) (*Effective July 1, 2004*) The Commissioner of Public
4 Safety shall provide a state-wide twenty-four-hour toll-free school
5 safety telephone hotline that shall be dedicated to receive reports of
6 threats or dangers concerning public or private schools and
7 institutions of higher education, teachers, students or administrators.
8 Such hotline shall be connected to any existing emergency telephone
9 hotline operated on a twenty-four-hour basis."
