**AN ACT CONCERNING THE DEMAND RESPONSIVE PROGRAM OF
TRANSPORTATION FOR ELDERS AND PERSONS WITH
DISABILITIES.**

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. Subsection (a) of section 13b-38bb of the general statutes is
2 repealed and the following is substituted in lieu thereof (*Effective*
3 *October 1, 2005*):

4 (a) Not later than January 1, 2000, then not later than October 1,
5 2000, and annually after October 1, 2000, the Commissioner of
6 Transportation [, within available General Fund appropriations,] shall
7 establish a state matching grant program, in accordance with the
8 provisions of this section, which shall be available to any municipality
9 upon application of such municipality. Such grants shall be expended
10 by such municipalities for elderly and disabled demand responsive
11 transportation programs that shall be available to persons age sixty or
12 older.

This act shall take effect as follows and shall amend the following sections:
