- 1 Strike sections 41 and 42 and insert the following in lieu thereof:
- 2 "Sec. 41. (NEW) (*Effective July 1, 2005*) One-third of the amount of
- 3 the increase in the appropriation to the Mashantucket Pequot and
- 4 Mohegan Fund for the fiscal year ending June 30, 2007, for Grants to
- 5 Towns, shall be distributed to municipalities that are members of the
- 6 Southeastern Connecticut Council of Governments and to any
- 7 distressed municipality that is a member of the Northeastern
- 8 Connecticut Council of Governments or the Windham Area Council of
- 9 Governments. Said amount shall be distributed proportionately to
- 10 each such municipality based on the total amount of payments
- 11 received by all such municipalities from said fund in the fiscal year
- 12 ending June 30, 2006, determined in accordance with section to 3-55j of
- 13 the general statutes, as amended by this act. The grants payable in
- 14 accordance with this section shall be determined prior to the
- 15 determination of grants pursuant to said section to 3-55j and shall not

16 be reduced proportionately if the total of the grants payable to each
17 municipality pursuant to said section exceeds the amount
18 appropriated for such grants with respect to such year. The payments
19 to municipalities authorized by this section shall be made in
20 accordance with the schedule set forth in section 3-55i of the general
21 statutes.

22 Sec. 42. (NEW) (*Effective July 1, 2005*) (a) For the fiscal year ending
23 June 30, 2006, the municipalities of Ledyard, Montville, Norwich,
24 North Stonington and Preston shall each receive a grant of two
25 hundred fifty thousand dollars which shall be paid from the
26 Mashantucket Pequot and Mohegan Fund established by section 3-55i
27 of the general statutes and which shall be in addition to the grants paid
28 to said municipalities pursuant to section 3-55j of the general statutes,
29 as amended by this act.

30 (b) For the fiscal year ending June 30, 2007, and each fiscal year
31 thereafter, the municipalities of Ledyard, Montville, Norwich, North
32 Stonington and Preston shall each receive a grant of seven hundred
33 fifty thousand dollars which shall be paid from said fund and which
34 shall be in addition to the grants paid to said municipalities pursuant
35 to section 3-55j of the general statutes, as amended by this act.

36 (c) The grants payable in accordance with this section shall be
37 determined prior to the determination of grants pursuant to said
38 section 3-55j and shall not be reduced proportionately if the total of the
39 grants payable to each municipality pursuant to said section exceeds
40 the amount appropriated for grants pursuant to section to 3-55i of the
41 general statutes with respect to each such year."
