**"AN ACT CONCERNING LEAVE FOR MUNICIPAL EMPLOYEES
 RESPONDING TO FIRE CALLS."**

1 After the last section, add the following and renumber sections and
 2 internal references accordingly:

3 "Sec. 501. (NEW) (*Effective January 1, 2006*) No collective bargaining
 4 agreement between a municipality and a municipal employee
 5 organization executed on or after the effective date of this section shall
 6 contain a requirement prohibiting a paid employee of a municipality
 7 from engaging in volunteer services as a firefighter, emergency
 8 medical technician, paramedic or ambulance driver during off-duty
 9 hours."
