**"AN ACT CONCERNING WORKERS' COMPENSATION
 COVERAGE FOR EMERGENCY SERVICES PERSONNEL
 RESPONDING TO EMERGENCIES OUTSIDE OF REGULAR
 EMPLOYMENT HOURS."**

1 Strike everything after the enacting clause and substitute the
 2 following in lieu thereof:

3 "Section 1. (NEW) (*Effective from passage*) No collective bargaining
 4 agreement between a municipality and a municipal employee
 5 organization executed on or after the effective date of this section but
 6 before September 30, 2007, shall contain a requirement prohibiting a
 7 paid employee of a municipality from engaging in volunteer services
 8 as a firefighter, emergency medical technician, paramedic or
 9 ambulance driver during off-duty hours."

This act shall take effect as follows and shall amend the following sections:		
Section 1	<i>from passage</i>	New section
