***AN ACT CONCERNING THE BOARD OF TRUSTEES FOR THE
COMMUNITY-TECHNICAL COLLEGES.***

Be it enacted by the Senate and House of Representatives in General
Assembly convened:

1 Section 1. Subsection (a) of section 10a-71 of the general statutes is
2 repealed and the following is substituted in lieu thereof (*Effective July*
3 *1, 2006*):

4 (a) There shall be a Board of Trustees for Community-Technical
5 Colleges to consist, except as otherwise provided in this section, of
6 twenty-four persons, twenty-two to be appointed by the Governor,
7 who shall reflect the state's geographic, racial and ethnic diversity, one
8 of whom shall be a regional community college or regional
9 community-technical college alumnus and one of whom shall be a
10 regional technical college or regional community-technical college
11 alumnus and two to be elected by the students enrolled at the
12 institutions under the jurisdiction of said board. Except as otherwise
13 provided, members appointed by the Governor shall serve for terms of
14 six years each from July first in the year of their appointment. On or

15 before August 15, 1989, the Governor shall appoint one member who
16 shall be a regional technical or community-technical college alumnus
17 for a term which shall expire on June 30, 1995, to replace the regional
18 community college alumnus whose term expires June 30, 1989, and
19 eight members who shall have expertise and experience in business,
20 labor, industry or the technical occupations, three for terms which
21 shall expire on June 30, 1991, three for terms which shall expire on June
22 30, 1993, and two for terms which shall expire June 30, 1995. Thereafter
23 the Governor shall appoint members of said board to succeed those
24 appointees whose terms expire, except that (1) with respect to the
25 members of such board of trustees who were members of the Board of
26 Trustees of the Regional Community Colleges prior to July 1, 1989, the
27 Governor shall appoint two members to replace the four members
28 whose terms expire on June 30, 1991, and shall appoint four members,
29 one of whom shall be a regional community or community-technical
30 college alumnus, to replace the five members whose terms expire on
31 June 30, 1993, and (2) with respect to the members of the board
32 appointed on or after July 1, 1989, and on or before August 15, 1989,
33 the Governor shall appoint one member to replace the three members
34 whose terms expire on June 30, 1991, and shall appoint two members
35 to replace the three members whose terms expire on June 30, 1993. On
36 and after July 1, 1993, the board shall at all times include at least six
37 members who have expertise and experience in business, labor or
38 industry. On and after July 1, 1999, the board shall at all times include
39 at least one member from each county in which a community-technical
40 college is located. On and after July 1, 2010, the board shall at all times
41 include at least two members who have, through education or
42 experience, an understanding of relevant accounting principles and
43 practices and financial statements.

This act shall take effect as follows and shall amend the following sections:
