**Title:** AN ACT CONCERNING ACCOUNTABILITY IN STATE ECONOMIC DEVELOPMENT ASSISTANCE.

**Statement of Purpose:** To require the Connecticut Development Authority and Connecticut Innovations, Incorporated to (1) develop specific procedures for votes by boards of directors when writing off outstanding loan or economic assistance, (2) record its evaluation and decision on each application for economic development assistance and make such evaluation and decision subject to the Freedom of Information Act, and (3) prohibit directors from having a financial interest in any applicant for economic assistance and to require the Connecticut Development Authority to submit an annual report on economic development activities similar to the one currently required from Connecticut Innovations, Incorporated.
