**Title:** AN ACT CONCERNING PREPAID FUNERAL CONTRACTS.

**Statement of Purpose:** To require specific information to be contained in all prepaid funeral contracts, to require escrow agents to make receipt acknowledgements and notifications regarding transfers of escrow funds, to require funeral homes to maintain written lists of escrow accounts, to authorize the placement of escrow funds in life insurance contracts, subject to certain provisions, and to require notification to beneficiaries upon transfer of a prepaid funeral contract to another funeral home.
