Title: AN ACT CONCERNING THE DEFINITION OF VETERAN AND THE REPORTING OF VETERAN'S BENEFITS.

Statement of Purpose: To amend the definition of "armed forces" to include the Connecticut National Guard and reserve components of the United States Army, Navy, Marine Corps, Coast Guard and Air Force; to revise certain definitions to conform with the United States Code; and to require the compilation of data regarding state benefits provided to veterans for use by the Military Department to recruit and retain military personnel.
