**Title:** AN ACT CONCERNING ASSESSMENTS FOR IMMUNIZATIONS.

**Statement of Purpose:** To provide with respect to the assessment made to fund payments to the Department of Public Health to purchase vaccines, each insurer shall be responsible for its share of the costs notwithstanding whether its assessment exceeds twenty-five per cent of the actual expenditures of the Insurance Department and the Office of the Healthcare Advocate.
