Title: AN ACT CONCERNING LIQUOR PERMITS AND INVESTIGATIONS REGARDING INDUCING MINORS TO PROCURE LIQUOR.

Statement of Purpose: To exclude landlords and franchisors from being considered backers of liquor permits under certain circumstances, to allow the Liquor Control Commission to proceed with a remonstrance that was properly filed by ten residents and to provide a mechanism to withdraw a remonstrance prior to the start of a hearing, to allow the Liquor Control Commission to proceed with administrative hearings even though a criminal proceeding concerning the same matter failed to result in a criminal conviction and to allow the Liquor Control Division of the Department of Consumer Protection to conduct alcohol compliance checks without having local or state law enforcement officers present.
