Title: AN ACT CONCERNING RECONSIDERED AGENCY DECISIONS AND APPEALS UNDER THE UNIFORM ADMINISTRATIVE PROCEDURE ACT.

Statement of Purpose: To provide that a reconsidered decision in a contested case shall be the final decision in the contested case for all purposes, including the appeal of issues decided only in the original agency decision for which reconsideration was not sought or granted by the agency, and to establish a deadline by which a reconsidered decision must be rendered by the agency.
