**Title:** AN ACT CONCERNING CRIMINAL JUSTICE POLICY AND PLANNING AND THE ESTABLISHMENT OF A SENTENCING TASK FORCE.

**Statement of Purpose:** To promote the rehabilitation of offenders by authorizing the issuance of a certificate of employability to assist eligible offenders in overcoming barriers to being employed or holding state licenses or permits, and to authorize the Board of Pardons and Paroles to grant provisional pardons and certificates of rehabilitation.
