Title: AN ACT CONCERNING MUNICIPAL PENSION DEFICIT FUNDING BONDS.

Statement of Purpose: To clarify state statutes concerning municipal postemployment health and life benefit systems; to revise state statutes regarding municipal retiree benefit reserve funds in order to facilitate the transfer of funds held in such reserves to pension, retirement and OPEB (Other Post Employment Benefits) trusts; and to update the statutes with respect to the issuance of pension obligation bonds by municipalities.
