Title: AN ACT ENABLING THE DEPARTMENT OF REVENUE SERVICES TO PROCESS RETURNS MORE EFFICIENTLY.

Statement of Purpose: To (1) eliminate requiring a taxpayer to file either an approval letter or certificate when claiming a credit on a tax return, (2) repeal the gross earnings tax on the express telegraph business, and (3) clarify the current administration of the Business Entity Tax.
