AN ACT EXPANDING THE STATE EMPLOYEE HEALTH INSURANCE PLAN.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 That section 5-259 of the general statutes be amended to expand the
- 2 state employee health insurance plan to self-employed and other
- 3 individuals who lack health insurance and to require the Comptroller
- 4 to negotiate quality health insurance coverage for such expanded pool
- 5 at a low cost.
