**AN ACT CONCERNING APPROPRIATIONS FOR INVESTMENTS IN  
EMPLOYER AND COMMUNITY-BASED WORKFORCE  
DEVELOPMENT ACTIVITIES.**

Be it enacted by the Senate and House of Representatives in General Assembly convened:

1 Section 1. (*Effective July 1, 2007*) (a) The additional sum of one  
2 million dollars is appropriated to the Office of Workforce  
3 Competitiveness, from the General Fund, for the fiscal year ending  
4 June 30, 2008, for adult education programs.

5 (b) The additional sum of one million dollars is appropriated to the  
6 Office of Workforce Competitiveness, from the General Fund, for the  
7 fiscal year ending June 30, 2009, for adult education programs.

8 Sec. 2. (*Effective July 1, 2007*) (a) The additional sum of eight hundred  
9 thousand dollars is appropriated to the Office of Workforce  
10 Competitiveness, from the General Fund, for the fiscal year ending  
11 June 30, 2008, for vocational and technical training in workforce  
12 shortage areas.

13 (b) The additional sum of eight hundred thousand dollars is  
14 appropriated to the Office of Workforce Competitiveness, from the  
15 General Fund, for the fiscal year ending June 30, 2009, for vocational  
16 and technical training in workforce shortage areas.

17 Sec. 3. (*Effective July 1, 2007*) (a) The additional sum of five hundred

18 thousand dollars is appropriated to the Office of Workforce  
19 Competitiveness, from the General Fund, for the fiscal year ending  
20 June 30, 2008, for financial assistance for post-secondary education in  
21 workforce shortage areas.

22 (b) The additional sum of five hundred thousand dollars is  
23 appropriated to the Office of Workforce Competitiveness, from the  
24 General Fund, for the fiscal year ending June 30, 2009, for financial  
25 assistance for post-secondary education in workforce shortage areas.

26 Sec. 4. (*Effective July 1, 2007*) (a) The additional sum of one million  
27 five hundred thousand dollars is appropriated to the Office of  
28 Workforce Competitiveness, from the General Fund, for the fiscal year  
29 ending June 30, 2008, for incumbent worker training programs.

30 (b) The additional sum of one million five hundred thousand dollars  
31 is appropriated to the Office of Workforce Competitiveness, from the  
32 General Fund, for the fiscal year ending June 30, 2009, for incumbent  
33 worker training programs.

34 Sec. 5. (*Effective July 1, 2007*) (a) The additional sum of seven  
35 hundred fifty thousand dollars is appropriated to the Office of  
36 Workforce Competitiveness, from the General Fund, for the fiscal year  
37 ending June 30, 2008, for career services for workforce development.

38 (b) The additional sum of seven hundred fifty thousand dollars is  
39 appropriated to the Office of Workforce Competitiveness, from the  
40 General Fund, for the fiscal year ending June 30, 2009, for career  
41 services for workforce development.

42 Sec. 6. (*Effective July 1, 2007*) (a) The additional sum of two hundred  
43 thousand dollars is appropriated to the Office of Workforce  
44 Competitiveness, from the General Fund, for the fiscal year ending  
45 June 30, 2008, for technical assistance and evaluation of the workforce  
46 development strategies funded in sections 1 to 5, inclusive, of this act.

47 (b) The additional sum of two hundred thousand dollars is

48 appropriated to the Office of Workforce Competitiveness, from the  
49 General Fund, for the fiscal year ending June 30, 2009, for technical  
50 assistance and evaluation of the workforce development strategies  
51 funded in sections 1 to 5, inclusive, of this act.

52 Sec. 7. (*Effective July 1, 2007*) The Office of Workforce  
53 Competitiveness shall ensure that the workforce development  
54 activities described in sections 1 to 5, inclusive, of this act are available  
55 for ex-inmates.
