***AN ACT CONCERNING WORKFORCE ADVANCEMENT GRANTS FOR
LOW-INCOME STUDENTS.***

Be it enacted by the Senate and House of Representatives in General
Assembly convened:

1 Section 1. Section 10a-72f of the general statutes is repealed and the
2 following is substituted in lieu thereof (*Effective July 1, 2007*):

3 [Within available appropriations, the Board of Trustees for
4 Community-Technical Colleges may establish up to three pilot
5 programs to provide for student household and family expenses of
6 students with dependents while such students are attending a
7 community-technical college. Participation in the pilot program shall
8 be limited to students who are eligible for a federal Pell grant.]

9 The Board of Trustees of the Community-Technical Colleges shall
10 establish, within available appropriations, pilot programs at Gateway
11 Community Technical College, Housatonic Community College and
12 Quinebaug Valley Community College to provide workforce
13 advancement grants to assist students from low-income families with
14 the direct and indirect costs of education. Grants under the program
15 shall be based on financial need. The Board of Trustees of the

16 Community-Technical Colleges shall develop eligibility requirements
17 for recipients. Such requirements may include income guidelines.

18 Sec. 2. (NEW) (*Effective July 1, 2007*) The Board for State Academic
19 Awards shall establish, within available appropriations, a pilot
20 program at Charter Oak State College to provide workforce
21 advancement grants to assist students from low-income families with
22 the direct and indirect costs of education. Grants under the program
23 shall be based on financial need. The Board for State Academic
24 Awards shall develop eligibility requirements for recipients. Such
25 requirements may include income guidelines.

26 Sec. 3. (*Effective July 1, 2007*) The sum of one million two hundred
27 fifteen thousand dollars is appropriated to the Regional Community-
28 Technical Colleges, from the General Fund, for the fiscal year ending
29 June 30, 2008, for the purposes of section 1 of this act.

30 Sec. 4. (*Effective July 1, 2007*) The sum of one hundred forty thousand
31 dollars is appropriated to Charter Oak State College, from the General
32 Fund, for the fiscal year ending June 30, 2008, for the purposes of
33 section 2 of this act.
