Title: AN ACT CONCERNING THE RETENTION OF STATE JOBS.

Statement of Purpose: To require that providers of services under state contracts identify whether such services will be performed outside the United States, to require providers of services under state privatization contracts use reasonable efforts to provide such services in the United States and to give preference to supplies, materials and equipment produced, assembled or manufactured in the state or United States and to services originating and provided in the state or United States.
