Title: AN ACT CONCERNING THE APPOINTMENT AND POWERS OF CONSERVATORS AND SPECIAL LIMITED CONSERVATORS WITH RESPECT TO PSYCHIATRIC TREATMENT.

Statement of Purpose: To (1) clarify the burden of proof with respect to (A) appointment of conservators and special limited conservators with specific authority to consent to a patient's psychiatric treatment, and (B) orders authorizing the administration of medication to certain patients, and (2) allow a special limited conservator to release a patient's medical records pursuant to an order by the Probate Court.
