**Title:** AN ACT CONCERNING COSTS AND ATTORNEY'S FEES IN AN ACTION UPON A BOND SUBSTITUTED FOR A MECHANIC'S LIEN.

**Statement of Purpose:** To permit a defendant in a negligence action to allege that another person, including a person who is immune from liability under worker's compensation law, was a substantial factor in causing the plaintiff's injuries or damages, and to clarify provisions concerning the award of costs and attorney's fees in an action of foreclosure of a mortgage or lien or an action upon a bond which has been substituted for a mechanic's lien.
