Title: AN ACT CONCERNING RESOURCE RECOVERY OUTPUT PURCHASE REQUIREMENTS AND INDIRECT COSTS AND REMEDIES FOR PUBLIC SERVICE COMPANIES.

Statement of Purpose: To amend the avoided cost rates for electric output; to eliminate the requirement that electric companies contract with resource recovery facilities to purchase electricity generated from waste originating in the company's franchise area; to allow gas companies to reconcile their indirect commodity costs; and to provide utility receivership remedy to utilities when nursing homes do not pay for services.
