**Title:** AN ACT CONCERNING THE RISK ASSESSMENT BOARD, THE DISSEMINATION OF REGISTRATION INFORMATION OF SEXUAL OFFENDERS AND THE MANDATED REPORTING OF THE SEXUAL ABUSE OF CHILDREN.

**Statement of Purpose:** To revise the date that the Risk Assessment Board is required to submit its findings and recommendations to the legislature, to authorize a victim of sexual assault to petition the court to make registration information for certain sexual offenders the dissemination of which had been restricted available to the public, to make persons who service or repair computers mandated reporters of child abuse or neglect and to provide an extended period of time for persons who were sexually abused as children to seek civil remedies or a criminal prosecution.
