**Title:** AN ACT CONCERNING HAND-HELD MOBILE TELEPHONES AND HAND-HELD MOBILE ELECTRONIC DEVICES.

**Statement of Purpose:** To require state and municipal police departments to collect, record and report information regarding violations of section 14-296aa of the general statutes, to require the Department of Public Safety to annually submit a report regarding such information to the joint standing committee of the General Assembly having cognizance of matters relating to transportation, and to permit the Department of Transportation to increase signage on the state's highways regarding hand-held mobile telephone and hand-held mobile electronic devices laws.
