**Title:** AN ACT CONCERNING THE SOLICITATION OF CHARITABLE FUNDS ACT AND PROVIDING MUNICIPALITIES WITH THE AUTHORITY TO REGULATE CHARITABLE DONATION BINS.

**Statement of Purpose:** To require donation bins in public places to contain certain disclosures, allow municipalities to regulate donation bins, allow the Commissioner of Consumer Protection to waive late fees and audit reports, change the filing deadline for late financial reports and increase the registration fee for fund-raising counsel.
