**Title:** AN ACT CONCERNING SCHOOL BULLYING.

**Statement of Purpose:** To broaden the definition of "bullying", to add a fine for noncompliance with the reporting provisions of antibullying policies, to withhold education cost sharing funds from districts that fail to develop and adhere to district-wide antibullying policies, to provide funds for school districts to have school-wide antibullying assemblies and to require in-service training for teachers and administrators in the prevention of bullying.
