Title: AN ACT CONCERNING WHOLESALE BEER PRICE POSTING AND MODIFYING BEER PACKAGING FOR CONSUMPTION ON AND OFF PREMISES.

Statement of Purpose: To allow beer manufacturers, wholesalers and out-of-state shipper permittees to differentiate in the manner in which their products are packaged on the basis of on-site or off-site consumption and to require wholesale postings for beer to be provided to retail permittees by the twentieth day of each month.
