**Title:** AN ACT CONCERNING COVERAGE BY THE CONNECTICUT INSURANCE GUARANTY ASSOCIATION.

**Statement of Purpose:** To authorize the Insurance Commissioner to disapprove rates for homeowners insurance policies that are excessive, inadequate or unfairly discriminatory and to increase from three hundred thousand dollars to five hundred thousand dollars coverage by the Connecticut Insurance Guaranty Association with respect to covered property and casualty claims.
