**Title:** AN ACT ESTABLISHING AN EQUINE ADVISORY COUNCIL.

**Statement of Purpose:** To allow the Commissioner of Environmental Protection to require any person to furnish information or documentation in furtherance of the provisions of title 22a of the general statutes, to make the criminal penalties for failing to maintain or destroying information concerning air, water, solid and hazardous waste violations consistent, and to make the idling of a motor vehicle an infraction.
