**Title:** AN ACT CONCERNING LICENSED ENVIRONMENTAL PROFESSIONALS.

**Statement of Purpose:** To authorize sanctions other than revocation or suspension of a licensed environmental professional (LEP) license, to dispense with the requirement that the commissioner respond in writing when delegating authority for site remediation to a LEP, to require verification that the investigation was done in accordance with prevailing standards and to require that LEP verification be done on a form prescribed by the commissioner.
