Title: AN ACT AUTHORIZING THE METROPOLITAN DISTRICT COMMISSION TO IMPOSE A SURCHARGE TO COVER THE COSTS OF IMPLEMENTING THE CLEAN WATER PROJECT, ADOPT PROCUREMENT PROCESSES AND COMPLY WITH MINORITY HIRING AND SET-ASIDE GOALS.

Statement of Purpose: To authorize the Metropolitan District Commission to establish (1) fees to pay the cost of compliance with a federal order to abate pollution from combined sewer system overflows, sanitary system overflows and nitrogen discharges, and (2) procurement processes and limits for the contracting of goods and services.
