Title: AN ACT CONCERNING AMUSEMENT PATRONS' SAFETY.

Statement of Purpose: To prohibit riders of an amusement ride or device from engaging in behavior that could cause injury to themselves or others, to require parents or guardians to ensure that the rider complies with the provisions of this act, and to make a violation punishable by an up to one-thousand-dollar fine or up to six months imprisonment.
