Title: AN ACT CONCERNING YOUTH OPPORTUNITIES AND URBAN REVITALIZATION.

Statement of Purpose: To provide tax credits for affordable housing and funds to eligible municipalities for (1) urban youth enrichment, (2) establishment of a one-stop center connecting urban youth to organizations providing youth employment opportunities, tutoring and mentoring services, juvenile justice diversionary programs and enrichment and recreation activities, (3) development of successful strategies to help youth build career competencies, obtain career experience and training, (4) establishment of mentoring opportunities for public employees, and (5) arts education and related training to local youth.
