**"AN ACT ESTABLISHING A TASK FORCE TO STUDY THE  
RECOMMENDATIONS OF THE OFFICE OF STATE ETHICS  
CONCERNING MUNICIPAL ETHICS."**

1 After the last section, add the following and renumber sections and  
2 internal references accordingly:

3 "Sec. 501. Subsection (b) of section 1-83 of the general statutes is  
4 repealed and the following is substituted in lieu thereof (*Effective from*  
5 *passage*):

6 (b) (1) The statement of financial interests, except as provided in  
7 subdivision (2) of this subsection, shall include the following  
8 information for the preceding calendar year in regard to the individual  
9 required to file the statement and the individual's spouse and  
10 dependent children: [residing in the individual's household:] (A) The  
11 names of all businesses with which associated; (B) [the category or  
12 type of] all sources of income, including the name and address of each  
13 employer, with a description of each source, in excess of one thousand  
14 dollars, without specifying amounts of income; (C) the name of

15 securities in excess of five thousand dollars at fair market value owned  
16 by such individual, spouse or dependent children or held in the name  
17 of a corporation, partnership or trust for the benefit of such individual,  
18 spouse or dependent children; (D) the existence of any known blind  
19 trust and the names of the trustees; (E) all real property and its  
20 location, whether owned by such individual, spouse or dependent  
21 children or held in the name of a corporation, partnership or trust for  
22 the benefit of such individual, spouse or dependent children; (F) the  
23 names and addresses of creditors to whom the individual, the  
24 individual's spouse or dependent children, individually, owed debts of  
25 more than ten thousand dollars; (G) any leases or contracts with the  
26 state held or entered into by the individual or a business with which he  
27 or she was associated; and (H) a description of any partnership, joint  
28 ownership or similar business affiliation between (i) a business  
29 included under subparagraph (A) of this subdivision with which the  
30 individual filing the statement, the individual's spouse or a dependent  
31 child of the individual is associated, and (ii) a lobbyist, a person that  
32 the individual filing the statement knows or has reason to know is  
33 doing business with or seeking to do business with the state or is  
34 engaged in activities that are directly regulated by the department or  
35 agency in which the individual is employed, or a business with which  
36 such lobbyist or person is associated.

37 (2) The statement of financial interests filed by state marshals shall  
38 include only amounts and sources of income earned in their capacity  
39 as state marshals."
