AN ACT CONCERNING VOLUNTEER SERVICE BY PAID EMERGENCY PERSONNEL OR PAID FIREFIGHTERS.

**Action:** Failed

**Language Change:** "Notwithstanding any provisions in any contract to the contrary, paid firefighters or paid emergency personnel may apply to the municipality by which they are employed to serve as an active member of a volunteer fire department in the municipality in which such paid firefighters or emergency personnel reside during personal time. Such application shall be granted provided that the municipality by whom the paid firefighters or paid emergency personnel are employed reach an agreement concerning which of said municipalities shall be responsible for: 1) workers' compensation claims for injuries sustained by paid firefighters or paid emergency personnel under circumstances where it is not determinable whether said injuries were sustained by the firefighters or emergency personnel while in service to the municipality which employs them or the municipality for which volunteer services are performed; 2) overtime and other substitute personnel costs of the municipality employing paid firefighters or emergency personnel when said paid firefighters or emergency personnel are injured while performing volunteer service for the municipality in which they reside; 3) increases in the premiums for workers' compensation coverage and health insurance coverage for the municipality employing the paid firefighters and emergency personnel."
