"AN ACT CONCERNING REGULATION OF THE SECONDARY MARKET IN PHYSICIAN DISCOUNTS."

1 After the enacting clause, insert the following and renumber the
2 remaining sections and internal references accordingly:

3 "Section 1. (NEW) (*Effective January 1, 2009*) (a) As used in this
4 section and sections 2 and 3 of this act:

5 (1) "Contracting entity" means any entity that contracts directly with
6 a health care provider (A) for the delivery of health care services, or (B)
7 for the selling, leasing, renting, assigning or granting of access to a
8 contract or terms of a contract. For the purposes of this section, a
9 health care provider is not a contracting entity.

10 (2) "Covered entity" means any entity that has not contracted
11 directly with a health care provider but that buys, leases, rents, is
12 assigned or accesses a contract or terms of a contract with a health care
13 provider, that is responsible for (A) the payment or coordination of

14 health care services, or (B) the establishment or extension of health care
15 provider networks.

16 (3) "Health care provider" means any physician, physician group,
17 physician network, independent practice association, physician
18 organization or physician hospital organization.

19 (4) A contracting entity sells, leases, rents, assigns or grants access to
20 a contract or terms of a contract to a covered entity for the purposes of
21 this section and sections 2 and 3 of this act when such contracting
22 entity is not involved in the administration of the benefit plan
23 responsible for the payment of health care services provided by such
24 plan."

44 "which such provider's services, discounted rates or fees has been sold,

55 "(c) Each covered entity shall pay the health care provider's
56 discounted rates or fees in accordance with the terms and conditions
57 set forth in the contract between the contracting entity and such
58 provider."

68 After line 32, insert the following and renumber sections and
69 internal references accordingly:

70 "(f) On and after January 1, 2009, any contracting entity or covered
71 entity that issues a member identification card shall clearly mark on
72 such card the address of the Internet web site or toll-free telephone
73 number set forth in subdivision (1) of subsection (b) of section 2 of this
74 act."

75 After the last section, add the following and renumber sections and
76 internal references accordingly:

77 "Sec. 501. (NEW) (*Effective January 1, 2009*) Nothing in section 1 or 2
78 of this act shall be construed to apply to any contracting entity that
79 sells, leases, rents, assigns or grants access to a health care provider's
80 health care services, discounted rates or fees to: (1) Any entity under
81 common ownership or control with such contracting entity; (2) any
82 entity providing or receiving administrative services or insurance from
83 such contracting entity or any entity under common ownership or
84 control with such contracting entity; (3) any independent entity
85 operating under the same licensee program and brand as such
86 contracting entity; or (4) any entity providing or receiving
87 administrative services or insurance from an independent entity
88 operating under the same licensee program and brand as such
89 contracting entity.

90 Sec. 502. (NEW) (*Effective January 1, 2009*) The provisions of sections
91 1 and 2 of this act shall not apply to the delivery of health care services
92 for the purposes of workers' compensation benefits pursuant to
93 chapter 568 of the general statutes."
