Title: AN ACT CONCERNING ISSUANCE OF EMERGENCY CERTIFICATES BY LICENSED CLINICAL SOCIAL WORKERS AND ADVANCED PRACTICE REGISTERED NURSES.

Statement of Purpose: To permit licensed clinical social workers and advanced practice registered nurses who have received either specialized crisis intervention team training or advanced supervision and intervention support team training to issue emergency certificates directing that a person be taken to a general hospital for purposes of a medical examination.
