Title: AN ACT CONCERNING THE DESIGNATION OF ALL-TERRAIN VEHICLE TRAILS, A TRAIL USER FEE AND ALL-TERRAIN VEHICLE REGISTRATION.

Statement of Purpose: To require all purchasers of an all-terrain vehicle to pay a one per cent user fee, to create an all-terrain vehicle account to be used for trail maintenance, enforcement and administration costs of the Department of Environmental Protection and for grants to an all-terrain vehicle association for safety and education courses, and to require the Department of Environmental Protection to designate four trails for all-terrain vehicle use by January 1, 2009.
