Title: AN ACT CONCERNING ELIGIBILITY FOR EMERGENCY HOUSING ASSISTANCE FROM THE DEPARTMENT OF SOCIAL SERVICES.

Statement of Purpose: To allow eligibility for emergency housing benefits for foreclosure defendants to be triggered when a foreclosure judgment is entered, rather than when the property owner's right to redeem has expired.
