Title: AN ACT CONCERNING SCHOOL LEARNING ENVIRONMENT.

Statement of Purpose: To require change orders to be submitted no later than six months after the issuance of such orders for reimbursement, to make a conforming change to provisions concerning title reversion for projects reimbursed at a rate of ninety-five per cent or more and to require construction sites to be secured prior to application for a grant.
