Title: AN ACT CONCERNING THE IMPOUNDMENT OF ROAMING ANIMALS AND PUBLIC SAFETY.

Statement of Purpose: To enable animal control officers to impound roaming livestock and certain flightless birds, to establish an owner and keeper notification process, to establish fines for noncompliance by such owners and keepers and to enable municipal animal control officers to dispose of such livestock and flightless birds, subject to certain conditions.
