Title: AN ACT CONCERNING FAMILIES WITH SERVICE NEEDS.

Statement of Purpose: To (1) make minor revisions to the family with service needs statutes in accordance with the recommendations of the Family with Service Needs Advisory Board, (2) establish pilot programs and provide funding in accordance with the recommendations of said board, (3) permit a parent to request from the Department of Public Health a certificate of birth resulting in stillbirth, (4) establish a community-based pilot program to provide additional reentry and diversionary services for youth, and (5) study the feasibility of establishing a separate drug court for offenders under the age of eighteen.
