Title: AN ACT CONCERNING THE OFFENSE OF DRIVING UNDER THE INFLUENCE AND IGNITION INTERLOCK DEVICES.

Statement of Purpose: To increase the license suspension period for offenders with a first conviction for driving under the influence from one year to eighteen months; to allow said offenders to apply for the installation of an ignition interlock device on their vehicles in lieu of serving the final twelve months of their suspension; to require that offenders with a first conviction for driving under the influence participate in a substance treatment program prior to installing an ignition interlock device; and to change the period where ignition interlock devices are required for those who are granted a reinstatement of their license after a third or subsequent conviction for driving under the influence from the period remaining until ten years has passed from the time of revocation to a fixed period of four years from the time of reinstatement.
