**Title:** AN ACT CONCERNING PARKING FOR PERSONS WHO ARE BLIND AND PERSONS WITH DISABILITIES WHICH LIMIT OR IMPAIR THE ABILITY TO WALK.

**Statement of Purpose:** To revise and improve the process for the renewal of windshield placards which allow parking in spaces reserved for persons with disabilities, to require a recall of existing placards, and to develop methods for strengthened enforcement of statutory and regulatory provisions concerning parking in such spaces.
