Title: AN ACT CONCERNING THE COURT SUPPORT SERVICES DIVISION OF THE JUDICIAL BRANCH.

Statement of Purpose: To authorize probation officers to detain wanted persons, seize and possess contraband, participate in fugitive task forces and notify police officers of persons in violation of their probation, revise the position titles of certain employees, revise the fee paid for electronic monitoring services, repeal the zero tolerance drug supervision program, extend the period of retention of records of a person's participation in the alcohol education program and clarify the applicability of provisions concerning contracted space for probation officers.
