**Title:** AN ACT PROVIDING STATE-FUNDED MEDICAL COVERAGE TO CHILDREN IN THE CARE OF THE DEPARTMENT OF CHILDREN AND FAMILIES AND THE DEPARTMENT OF DEVELOPMENTAL SERVICES.

**Statement of Purpose:** To expand eligibility for state-funded medical assistance to include children under the care and supervision of the Department of Developmental Services who are ineligible for Medicaid and to remove the institutional status of a child from being a factor in determining a child's eligibility for medical assistance.
